

- **4.** no-fault auto insurance: A system under which drivers must have coverage for their own protection. It also limits the damages for which an injured party can sue. Under this system, after an accident both parties would be covered by their own insurance policies. Only some states use this
- **7.** annual percentage rate (APR): A number calculated by taking into account the total cost of a loan, including what the borrower will pay in interest; this makes it easier to compare different loan
- **8.** coupe: A car with two front seats and a smaller backseat for occasional passengers. It usually has two doors but sometimes has
- **9.** liability insurance: Insurance that compensates an injured party up to a certain amount outlined in the policy statement. This type of insurance ensures you will be able to pay for any damages you
- **10.** minivan: A car that is designed for maximum passenger space. It has multiple rows of seats but often doesn't offer significant towing power or off-road
