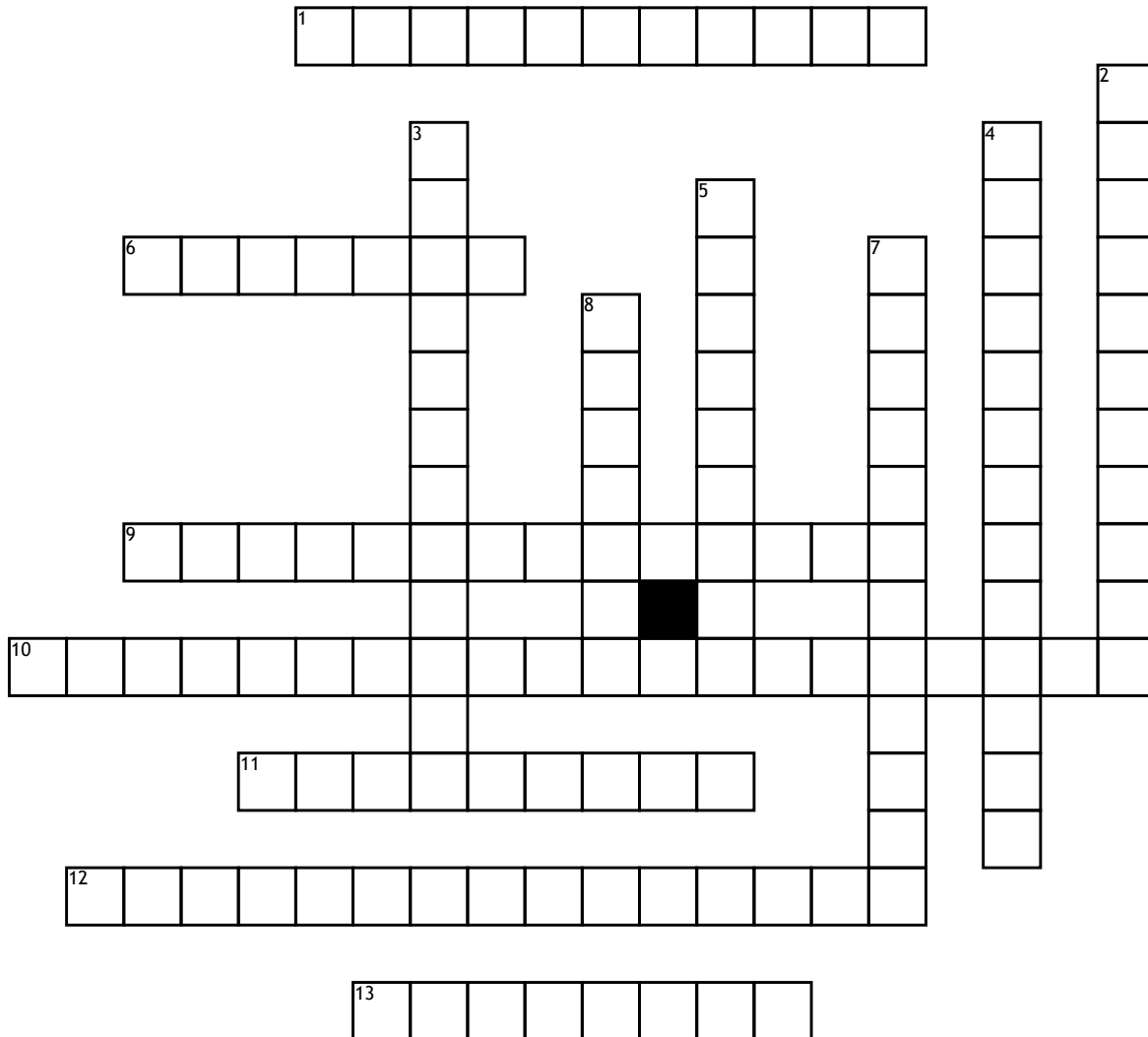


CREDIT CROSSWORD
