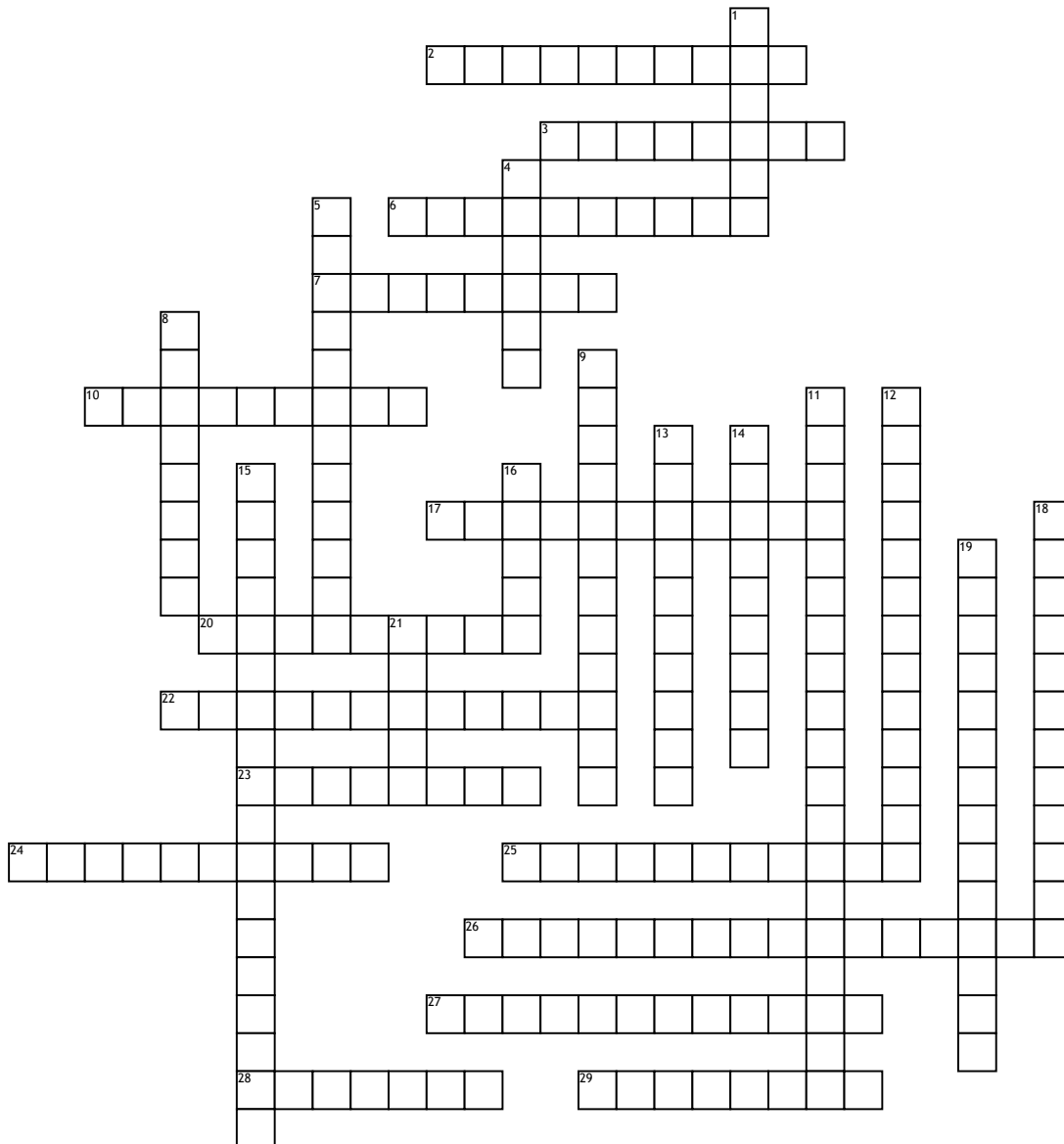

26. passed by the United States Congress on September 18, 1850, as part of the Compromise of 1850 between Southern slave-holding interests and Northern Free-Soilers.

27. the fact or process of being set free from legal, social, or political restrictions; liberation.

28. a legal or economic system in which principles of property law are applied to humans allowing them to be classified as property, to be owned, bought and sold accordingly, and they cannot withdraw unilaterally from the arrangement.

29. an act or means of sealing off a place to prevent goods or people from entering or leaving.

13. Abraham Lincoln was the 16th President of the United States, serving from March 1861 until his assassination in April 1865

14. Southern whites who supported Reconstruction and the Republican Party, after the American Civil War.

15. an effort by Congress to defuse the sectional and political rivalries triggered by the request of Missouri late in 1819 for admission as a state in which slavery would be permitted.

16. the state of being united or joined.

18. a person who favors the abolition of a practice or institution, especially capital punishment or (formerly) slavery.

19. an American politician who was a U.S. Representative and Senator from Mississippi, the 23rd U.S. Secretary of War, and the President of the Confederate States of America during the American Civil War.

21. a person who rises in opposition or armed resistance against an established government or ruler.
